



## **Sanchez Charter School School Parental Involvement Policy 2017-2018**

### **PART I. GENERAL EXPECTATIONS**

Sanchez Charter School agrees to implement the following statutory requirements:

The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning, evening, so that many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to attend the meeting, and will encourage them to attend, by:
  - *Notify parents of the annual Title I meeting through School Messenger, Open House/Title I flyer invitation mail out and Personal Phone calls.*
  
4. **Sanchez Charter School** will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by.
  - *conducting an annual meeting about Title I Programs that includes a description of the school's curriculum, the forms o academic assessment used to measure children's progress, and the proficiency levels students are expected to meet.*
  - *notify parents of the annual Title I meeting through School Messenger, Open House/Title I flyer invitation mail out and Personal Phone calls.*
  
5. **Sanchez Charter School** will, at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
  - *scheduling a meeting to address parent concerns upon a parent request of a meeting.*

6. **Sanchez Charter School** will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:
  - *Mailing home an individual student report about the performance of their child on the State Assessment in at least Math, Language Arts, Social Studies and Science.*
  
7. **Sanchez Charter School** will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002):
  - *Mailing home a letter that provides a timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified to teach to each parent.*
  
8. **Sanchez Charter School** will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described below --
  - *the state's student academic achievement standards,*
  - *the state and local academic assessments including alternate assessments,*
  - *the requirements of Title I Part A,*
  - *how to monitor their child's progress, and*
  - *how to work with educators:*
  
9. **Sanchez Charter School** will provide materials and training to help parents work with their children in the areas of improving student achievement, (including literacy training and using technology, child development, child rearing and additional topics parents may request).
  - *Grade Level Orientations*
  - *Computer Classes*
  - *Houston Women Area Center parent classes*
  - *Planned Parenthood Sexual Education Curriculum*
  
10. **Sanchez Charter School** will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
  - *Conducting an annual meeting that will focus on collaboration of Sanchez Charter School and parents to educate its teachers, pupil services personnel, principals, and other staff members how to reach out to, communicate with, and build ties between parents and Sanchez Charter School.*
  - *group discussions during Faculty Meetings will be conducted on how to effectively communicate and work with parents.*

11. **Sanchez Charter School** will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with student support organizations such as Houston Community College, University of Houston. The school will also conduct other activities, such as parenting classes, that encourage and support parents in more fully participating in the education of their children, by:
- Conduct semi-annual financial aid awareness and workshops. Examples include: Financial Aid and scholarship night, advanced academic, college fair and senior meetings, Senior Graduation requirements.
  - Parents will be notified of these meetings through School Messenger, flyer mail out and personal calls.
12. **Sanchez Charter School** will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:
- *School and parent-program information will be posted on Sanchez Charter School website.*
  - *School and parent-program information will be mailed in both English and in Spanish.*
  - *Parents will be notified of school and parent program information through School Messenger, Flyer mail out, personal invitation calls.*
